

- iii. Fifteen years of Research or Design or Development or Technology Application or Operational Experience in the field of Cryptology and Information technology or Crypto Analysis or implementation of Crypto-Algorithms and their software versions in hardware or Testing of Crypto products.

Desirable:

- i. PhD Degree in Mathematics **or** Master's Degree in Engineering or Technology in the Mathematics and Computing or Computer Science from a recognised University or Institute;
- ii. Experience in Directing or Monitoring or Coordinating Multi-Disciplinary Research and Development projects and working experience in the field of Cryptology and Information technology or Crypto Analysis or implementation of Crypto-Algorithms and their software versions in hardware or Testing of Crypto products;



- iii. Certificate course in a Foreign language other than English from a recognized University or Institute.

Note-1: The Departmental Officers in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation. Similarly, deputationists shall not be eligible for consideration for appointment on promotion.

Note-2: The maximum age limit for appointment on deputation shall be not exceeding 58 years as on the closing date of the receipt of the application.

For Ex-Serviceman: Deputation/Re-employment

The Armed Forces personnel due to retire or who are to be transferred to reserve within a period of one year and having the requisite experience and qualifications prescribed shall also be considered. Such persons would be given deputation term upto the date on which they are due for release from the Armed Forces; thereafter, they may be continued on re-employment.


