Candidates are invited for appearing in Walk-In-Interview for the post of General Duty Medical Officers (GDMO) (Allopathic) in CGHS Raipur & Specialist in CGHS Nagpur, who have retired from Central Govt./State Government Service/PSUs for filling up of the vacant posts in CGHS dispensaries of Nagpur & Raipur under administrative control of Additional Director, CGHS, Nagpur respectively on a **purely temporary and on contract basis** as per set terms and conditions.

1.	Age on the Closing date of Application	Candidate must not have exceeded the age of 69 years.
2.	Education Qualification	a) For Specialist - i) P.G. Degree with 3 years' service in the relevant field. Or ii) P.G. Diploma with 5 years' service in the relevant field. b) For GDMO - Minimum qualification required MBBS degree.
3.	Remuneration	1) Retired from CHS i) As per the M.o.H.&F.W. Order No.A.12026/01/ 2022-CHS-I, dated 14.07.2023 & MoF Department of Expenditure O.M. F.No.3-25/2020-E.IIIA, dated 09.12.2020, the consolidated remuneration of the contractual GDMOs retired from CHS will be paid as pay drawn at the time of retirement minus basic Pension. ii) As per the Order No.A.12026/4/2017/ CHS-III, dated 26.10.2023 issued by the MoH&FW, CHS Division, New Delhi, the consolidated remuneration of Specialist of Teaching, Non-Teaching and Public Health sub cadre of Central Health Services appointed on contract basis will be as under:- a) For 1 st year contract appointment : Rs.1,23,500/- b) For 2 nd year contract appointment : Rs.1,30,000/- 2) Retired from State Govt./PSU i) As per the MoH&FW F.No.A.11019/01/2017-CGHS-I, dated 07.09.2017, the consolidated remuneration of engaged GDMOs will be Rs.75000/- per month. ii) As per the MoH&FW F.No.A.12026/4/2017-CHS-I, dated 10.08.2018, the consolidated remuneration of engaged Specialists will be Rs.95000/- per month for 1 st year & Rs.1,05,000/- for 2 nd year.

4.	Duration of Contract	Initially for a period of one year or till the attaining age of 70 years or till regular incumbent joins, whichever is earlier.
5.	Number of vacancies	i) 02 (two) GDMOs for CGHS Raipur ii) 01 (one) Medical Specialist & 01(one) Ophthalmologist for CGHS Nagpur.
6.	Place of Posting	i) The selected candidates (GDMOs) will be posted in any CGHS dispensary of Raipur under CGHS, Nagpur ii) The selected candidates (Specialists) will be posted in any CGHS dispensary of CGHS, Nagpur. (They will work under the control of the Chief medical Officer-In-Charge of the Dispensary, in which they will be posted.)
7.	Preference	Doctors who have worked in CGHS & Knowledge of computers shall be preferred.



OFFICE MEMORANDUM

Terms and Conditions regarding engagement of retired doctors on Contract.

With reference to the above mentioned subject the undersigned is directed to notify the following terms & conditions of engagement of retired doctors on contract basis :-

(a) **Period** :- the engagement shall be purely on contract basis for a period of one year and extendable up to attaining the age of 70 years or till a regular incumbent joins, whichever is earlier, afterwards the contract will cease to exist automatically.

(b) **Age** :- the engagement shall be up to attaining the age of 70 years.

(c) **Remuneration** :-

1) Retired from CHS

i) As per the M.o.H.&F.W. Order No.A.12026/01/ 2022-CHS-I, dated 14.07.2023 & MoF Department of Expenditure O.M. F.No.3-25/2020-E.IIIA, dated 09.12.2020, the consolidated remuneration of the contractual GDMOs retired from CHS will be paid as pay drawn at the time of retirement minus basic Pension.

ii) As per the Order No.A.12026/4/2017/ CHS-III, dated 26.10.2023 issued by the MoH&FW, CHS Division, New Delhi, the consolidated remuneration of Specialist of Teaching, Non-Teaching and Public Health sub cadre of Central Health Services appointed on contract basis will be as under:-

a) For 1st year contract appointment : Rs.1,23,500/-

b) For 2nd year contract appointment : Rs.1,30,000/-

2) Retired from State Govt./PSU

i) As per the MoH&FW F.No.A.11019/01/2017-CGHS-I, dated 07.09.2017, the consolidated remuneration of engaged GDMOs will be Rs.75000/- per month.


ii) As per the MoH&FW F.No.A.12026/4/2017-CHS-I, dated 10.08.2018, the consolidated remuneration of engaged Specialists will be Rs.95000/- per month for 1st year & Rs.1,05,000/- for 2nd year.


(d) **Allowance** :-She/He will not be entitled to any allowance such as Dearness Allowance, residential telephone, transport facility, residential accommodation, CGHS and medical reimbursement etc.(unless She/he is entitled for CGHS facility or otherwise.)

(e) **Leave** :- She/He will be entitled for 1.5 days for each completed month of service. Such leave should not be more than 7 days at a stretch or number of leave days available to

his/her credit at the time of sanction. S/He will not be entitled for EOL & leave without pay except on exigency like curfew, natural disasters or on self hospitalization. On the event of overstay beyond the sanctioned leave his/her contract is liable to be terminated.

- (f) TA/DA: No TA/DA shall be admissible for joining the assignment or on its completion.
- (g) NPA:- No Non practicing allowance shall be admissible. Private practice of any kind is not permitted.
- (h) Termination of Agreement:-
1. The Doctor is unable to address the assigned works.
 2. The performance of the doctor is not up to the satisfaction of the department.
 3. Any false information/declaration furnished suppression of any fact.
 4. She/he is found lacking in honesty and integrity, in public interest, the appointment can also be terminated at any time on either side by giving 7 days notice or by paying 7 days salary, without assigning any reason or to the recommendation of competent authority.
- (i) She/he shall agree to any other duty assigned to him/her by CMO I/c without any additional/extra allowance.
- (j) The engagement of contract is a full time job. Therefore s/he would not be permitted to take up any other assignment during the period of contract with the CGHS. She/he shall agree and perform all the duties performed by a regular CGHS Medical officer.
- (k) S/he should be medically fit for which a medical certificate from a Registered Medical Practitioner having at least MBBS degree will have to be submitted within a week joining.
- (l) An undertaking to the effect that she/he has no criminal cases/vigilance cases/disciplinary cases pending against him/her at the time of engagement.
- (m) On appointment, the engaged contractual doctors will be required to take an oath of allegiance to the Constitution of India or make a solemn affirmation to that effect in the prescribed Proforma.
- (n) Other terms and conditions will be applicable as per government guidelines.
- (o) The contractual engagement or renewal thereof, if any shall be governed exclusively by the terms & conditions herein after as stated above.
